- 2. The Company has availed the services of KFin Technologies Limited ('KFin') for conducting postal ballot through e- voting. Further KFin Technologies Limited has also been engaged for facilitating e- voting to enable the members to cast their votes electronically using e- voting system on special business sought to be transacted through postal ballot.
